Requirements:

-  10 to 15 years of professional experience in security.
-  Relevant security certifications, such as CPP or CSSM.
-  Formal training in adult education or equivalent certifications like CPOI.

Application Process:

- 1** Complete a detailed form outlining qualifications, experience, and training.
- 2** Document Assessment Review (DAR) conducted by peer MSI instructors.
- 3** Interview with MSIs to evaluate communication skills and in-depth knowledge.
- 4** Final review by the IFPO board.
- 5** Notification and official certification award.

Evaluation:

-  Comprehensive review of academic qualifications and experience.
-  Assessment of contributions to the industry, such as publications and training programs developed.
-  Interviews focused on teaching skills, problem-solving, and ethical judgment.
